

# WAIVER AND RELEASE AGREEMENT

Please read carefully before signing

This is a release of liability and waiver of certain legal rights

In consideration for being permitted to participate in the activities of Whitewing / Dove Hunting, I agree to the following Waiver and Release. I acknowledge that hunting and/or clay target shooting has inherent risks, hazards and dangers that cannot be eliminated, particularly in a wilderness environment.

I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession;
2. The risk of ear damage from noise;
3. The risk of injury from ammunition, clay targets and shot from other guns;
4. Walking in rugged and unfamiliar country, including encounters with wildlife, animals and insects;
5. Inclement weather conditions. (heat, cold, rain)

For eye and ear protection, we recommend you use ear plugs and protective eye glasses. If you do not you are doing so at your own choice.

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with Les Tisdale Hunting Service. I understand that these activities may require good physical conditioning and a degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is voluntary. No one is forcing me to participate and I elect to participate in spite of the risks.

**I AM VOLUNTARILY USING THE SERVICES OF LES TISDALE HUNTING SERVICE WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.**

Lastly, I for myself, heirs, successors, executors, and subrogees, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS Les Tisdale Hunting Service, their directors, officers, agents, employees, Land owners and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to:

- NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, or injury paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals, property or equipment, whether such damage, loss, injury paralysis, or death results from negligence of Whitewing/Dove Hunting, or from some other cause.
- I. for my heirs my successors. Executors, and subrogees further agree not to sue Les Tisdale Hunting Service as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of Whitewing Dove Hunting.
